Pierce County Health Department Permitting

All restaurants must obtain a TFE permit. A permit application will be forwarded to you by a festival staff after we receive your festival application.

No permit fee payment is required. The Festival will pay for a blanket permit.

TFE permit applications will be due completed to festival staff by June 11.
